Presentation from Police Chief Randal Beach

This was the first day of back to school for Emanuel County Schools. Chief Beach recalled that the former Mayor Eileen Dudley told him just how important school traffic is. Chief Beach presented the Police Department's annual report, highlighting some of the cases the department has been involved in.

Training for Courtware Software Solutions were provided yesterday.

Discussion of Emanuel County 2020 Census Resolution

Mayor Donaldson presented that the Census is important to cities obtaining monies.

Discussion of timber proceeds from the Carilee Coleman Park and Pop Boogie Recreation Complex

The timber harvesting is complete. There was approximately \$12,000 in timber proceeds from Carilee Coleman Park and \$7,000 in timber proceeds from Pop Boogie Field.

Discussion of application for rezoning by J. Marcus Allen for Parcel T09 022 from R-1 (Residential) to B-1 (Business)

This property is at the location of 5th Avenue and Highway 80 East. The Planning Commission will hear the request of Mr. Allen in approximately two weeks. Afterwards make a recommendation to the Commission.

Discussion of Twin City Drugs sidewalk project cost breakdown

Mayor Donaldson presented the ownership percentage and costs for the sidewalk project.

Discussion of creation of 2021 Centennial Committee

Next year will be Twin City's Centennial (100 years). Mayor Donaldson would like the Commission to form a committee to plan for the 100-year celebration.

Discussion of 2020 City Appointments

Mayor Donaldson read the City Appointments aloud. Commissioner Moody disapproves of the appointments. Mayor Donaldson advised Commissioner Moody to let his vote of no, reflect his opinion of the appointments.
