Presentation from Police Chief Kevin Jarriel

Mayor and Commissioners viewed monthly report.

Discussion of US Department of Justice (DOJ) Bureau of Justice Assistance Body-Worn Camera Grant Program.

Chief Jarriel will be applying for this grant to get body cameras for the department.

Discussion of 2026 Resurfacing Project preliminary cost estimates and application to the Georgia Transportation Infrastructure Bank (GTIB) for funding.

Mayor Donaldson briefed the City Commission on the next round of funding availability from GTIB and reviewed the preliminary cost estimates for the project. If funded, this grant opportunity will resurface all remaining roads in Twin City. There are (23) roads that remain to be resurfaced, and the estimated cost is \$1.1 million.
