#### **New Business**

A motion to approve \$45,161.68 to Sirens for Cities for a replacement emergency alert system as a SPLOST expenditure was made by Commissioner Brown. The motion was seconded by Commissioner Moody. The motion was approved unanimously.

A motion to approve the contract with J & T Environmental Services, Inc for Water & Sewer System management services was made by Commissioner Brown. The motion was seconded by Commissioner Landon. The motion was approved unanimously.

Motion to accept the Fireworks Grant award and approve the purchase of Fire Department safety equipment in the amount of \$24,516.00 from American Safety & Fire house was made by Commissioner Brown. The motion was seconded by Commissioner Landon. The motion was approved unanimously.

#### **Public Works Department Report**

Commissioner Brown stated Public Works have been very busy this month. The Commission was provided a summary of monthly activities for the department.

## **Finance Report**

Mayor Donaldson read aloud the fund balances, with the fund balance being \$949,431.98 as of end of April 2022. We will also be sending out delinquent letters for property taxes. At the end of April, there were 161 delinquent parcels.

### **Recreation Department Report**

Commissioner Landon stated the season is running well. Commissioner Landon, Huddie Culbreth, and Mayor Donaldson are working with a company to receive donated playground equipment for Pop Boogie Field. The equipment is valued at \$43,000. The playground is set to be installed on May 30, 2022. The closing ceremony of the 2022 season will be held May 14, 2022.

# **Fire Department Report**

Commission Moody reviewed the monthly activity report with the Commission.

#### **Presentation from Sirens for Cities**

Ed Wise with Sirens for Cities proposed to the City Commission to replace the current emergency alert system. The current system is more than 30 years old and needs replacing. Wise made (2) proposals to the City Commission, which was a battery-backed system and one without a battery backup. The Commission decided to proceed with the system with a battery backup in the amount of \$45,161.68. The new system will consist of (2) different sirens to cover all citizens.

# **Presentation from Police Chief Hank Whiters**

Chief Whiters reviewed the monthly activity report with the Commission. Chief Whiters informed the City Commission that he has two cadets for Police Academy in July.

# Discussion of bids for Water/Sewer System contractual services

There were two bids. Tindall Enterprises and J & T Environmental. The City will renew the contract with the lowest bidder - J & T Environmental.

# Discussion of TCFD Fireworks Grant award and equipment purchase

Fire Chief Grimes and the Twin City Fire Department has been awarded a Fireworks Grant in the amount of \$21,459.00 for the replacement of public safety equipment. Chief Grimes presented (2) quotes from American Safety & Firehouse and Municipal Emergency Services. The lowest bid was American Safety & Firehouse in the amount of \$24,516.00. The City will fund the difference in the expense as part of the match.

# Discussion of quotes for Public Works limb truck with grapple arm purchase

Mayor Donaldson presented (3) different quotes for the replacement of the limb truck with grapple arm. The quotes were for \$193,700.00, \$169,500.00, and \$188,500.00. The Commission decided to proceed with the lowest quote in the amount of \$169,500.00 to Solid Waste Applied Technologies (SWAT).

# Discussion of GEFA Water Meter Replacement Project bids and recommendation from City Engineer McClellan

The bid opening on April 19, 2022 only produced one quote from Brooks Brothers Construction, LLC, which exceeded the proposed budget. The City Commission decided to not accept the only bid and proceed with another bid package. Mayor Donaldson will notify City Engineer McClellan.

# Discussion of engineering costs on Water Isolation System construction from City Engineer McClellan

Mayor Donaldson presented the cost estimates for the installation of an isolation system for the city water system. The City Commission would like to reduce estimated costs by reducing the number of valves installed. Mayor Donaldson will notify City Engineer McClellan to work on another proposal.

# Discussion of Assessment of City Roads from City Engineer McClellan

City Engineer McClellan has inspected and rated all city roads and streets and rated the needs of each as: good, fair, or poor. The City Commission will use this tool to prepare of the resurfacing project planned for 2023.

# Discussion of bathroom quotes for Graymont Community Park
