Mayor pro tem Donaldson made a motion to approve up to but not to exceed \$26, 624.00 to Glenn Davis and Associates for the 2019-2020 City Property and Casualty Insurance renewal. The motion was seconded by Commissioner Fields; motion approved.

A motion to approve by resolution to adopt the 2019 City of Twin City Bicycle and Pedestrian Plan, was made by Mayor pro tem Donaldson. Commissioner Fields seconded the motion; the motion was approved.

Mayor pro tem Donaldson made a motion to approve the Schedule of Appointments for the Pop Boogie Recreation Complex Advisory Committee. Commissioner Fields seconded the motion; motion approved.

Mayor's Report - Mayor Eileen M. Dudley

Mayor Dudley has met with Mr. Anthony Bennett, Emanuel County Road Superintendent. Mr. Bennett expects to have the repairs on Parrish Pond Road, by the beaver pond, completed by July 15, 2019 or earlier. The mayor

was advised to keep the water level low. Commissioner Brown stated that there are beavers present again. The city is responsible for the maintenance of the sides of Highway 192 and Highway 192 Spur. The trees and weeds need to be cleaned out of the ditches.

The Mayor attended a census meeting.

The Mayor is assisting Ms. Culbreth with planning for the July 4th activities, which will include "Meet the Chief" reception.

The old jail has a new roof, John Whetsell estimates that the windows will cost approximately \$300 each, there are four windows.

The Millcreek Foundation has invited the city or Historic Twin City to apply for the Millcreek Grant. The foundation has an interest in the work that is being done on the cabin.

Main Street Report – Main Street Program Director Huddie Culbreth

The Memorial Day Service was held on May 27, 2019. Main Street has an advisory board that will meet on June 17, 2019.

Streets & Roads Department Report and Water & Sewer Department-Commissioner Jesse S. Brown

There are water lines that need to be replaced.

Mayor pro tem Donaldson read the fund balances aloud, the total fund balance as of the end of May being, \$568, 053.86.

Presentation from Police Chief Randal Beach and Discussion of Police Department vehicle purchases

Chief Beach submitted multiple documents, including taser and vehicle proposals. Officer Lewis Smith remains on Worker's Compensation. We have Marcus Hartwell from Oak Park Police Department; a confident officer

and he is doing fine. The painting crew is back, and the building is looking fantastic.

We should be a Terminal Agency, where we have NCIC and GCIC. The chief has hopes of hiring a Terminal Agency Coordinator, to work 20-hours per week.

There were phone calls and concerns about underage drinking. The department has sent an underage person with an ID that reads "under 21" and the person was able to buy alcohol at all establishments within the city limits except for one location. Those locations that sold to the underage person was cited.

The department wrote 50 citations during the month of May 2019. The Dodge Charger is out of service, we could purchase 2 cars for the price of 1 if we maintain and manage the vehicle fleet. There are 2 vehicles that were thought to be out of service that is still functioning, and we should be able to get more use out of those.

The taser that was previously acquired is a civilian model and cannot be used for law enforcement. Pepper spray is effective. Pepper spray is a good option for canines.

The chief has investigated Municipal Court software, to be in compliant with the open records act. Most cities around Twin City uses Courtware Solutions. The chief would like to explore some other options.

One citizen has called 113 times to complain about the ATV's in his area. Chief stated that the governing body may want to consider adopting an ATV

ordinance. The chief has included a copy of Woodstock, Georgia's ATV ordinance.

Discussion of 2019-2020 Property and Casualty Insurance renewal proposal by Glenn Davis & Associates

Mayor pro tem Donaldson discussed the insurance proposal presented by brokers, Glenn Davis & Associates. For the 2019-2020 year, the cost of insurance is \$26, 624.00, that is an increase of \$63.

Discussion of 2019 City of Twin City Bicycle and Pedestrian Plan prepared by the Heart of Georgia Altamaha Regional Commission

The plan was developed by Heart of Georgia Altamaha Regional Commission. The state funds for sidewalks are low.

Discussion of 2019 LMIG Safety Application Plan (SAP) Award

The city has received a check in the amount of \$20,000.

Discussion of 2018, 2019, and 2020 LMIG projects

The projects have been advertised in the local origin, The Blade. The bids are due by 2 P.M., June 25, 2019.

The following streets will be paved: Queen Street, Davis Street, Bell Street, Oak Street and Oak Street Extension.

Discussion of Twin City Drugs land survey

Mr. Donaldson of Donaldson Surveys presented the survey that he completed to determine the right-of-way at the front entrance of the Twin City Drugs Property owned by Dr. Kent Kicklighter.

Discussion of Hurricane Michael GEMA/FEMA Disaster Funds

The city has been awarded nearly \$16,000 in reimbursement funds for Hurricane Michael.

Discussion of Pop Boogie Recreation Complex Strategic Plan and Committee Appointments
