Presentation from Police Chief Hank Whiters

Chief Whiters took command as Chief of Police on August 20, 2020. Since then, he has completed a regularly scheduled GCIC audit. There were several items, which were minor in nature, that will need to be addressed. Chief Whiters has (2) applicants interested in part-time employment with the City. There were some storage issues with the body cameras, and those have been addressed.

Discussion of 2020 GMA Safety and Liability Management Grant for the purchase of body armor for Police Department.

We are working on getting all officers fitted for vests. GMA offers a reimbursement grant for items like body armor, as the City is a member of the Workers Compensation Self-Insurance Fund. The city can apply for up to \$3,000.00. Mayor Donaldson is working on the grant application.

Discussion of City of Twin City 2021 Request for Qualifications (RFQ) and awarding of 2021 CDBG Engineering Contract.

In conjunction with our 2019 CDBG project, the City is applying for another CDBG for 2021 to begin Phase 2 of the project scope. The City is required to hear proposals from engineering firms for the 2021 CDBG submission. The Heart of Georgia Altamaha Regional Commission, on behalf of the City, sent 12 Requests for Qualifications (RFQ), but there were only 4 firms to respond. The HOGARC prepared a summary report of the scoring of the submittals. The summary report is included in the minutes. Since G. Ben Turnipseed Engineers scored comparatively with the other firms, is currently the City's Engineering Firm, and is the Project Engineer for the City's 2019 CDBG project, the City Commission decided to continue with Turnipseed Engineers for the 2021 CDBG.

Discussion of CARES Act funding from State of Georgia Coronavirus Relief Fund.

The City has received its 1st draw of funds from the State. We must submit justification to the State for the funds received. Phase One was approved at \$26,713.02. Phase Two is now open, and we are waiting to hear if we were approved.

Discussion of new National Main Street Program requirements.

There are new requirements from the Georgia Main Street Program to remain in the program as a Downtown Affiliate. Mayor Donaldson and Main Street Manager Huddie Culbreth have reviewed the requirements and have spoken to the State Office. They feel the City can meet the new requirements and remain in the program.

Discussion of Georgia Cities Week- October 4-10, 2020 and Resolution.

For Georgia Cities Week 2020, the Main Street Program will host a Clean-Up Week, much like in previous years. She would like for citizens to be more involved and encourage others to clean-up. The City will have 3 dumpster locations throughout town on October 10th. The City will not be accepting tires.

Discussion of 2021 Centennial Celebrations.

The City is approaching 100 years of existence in 2021, from the combination of Summit and Graymont. Mayor Donaldson would like for the City to have an annual festival, which would begin in 2021. He also would like the City to have a different activity each month in the 2021 year. The Centennial Committee will meet once a month to get ideas and support for the events. Mayor Donaldson would like to kick-of the Centennial in January 2021 by replacing all City Limits signs with new ones.

Discussion of continued Old City Hall/Jail renovations.

Mayor Donaldson would like for this renovation to be done for the Centennial. John Fowler would like to finish what he started on the jail. The steps need to be finished and be sure they are safe; Commissioner Moody will check on this. The air unit needs to be updated and Commissioner Moody will look at that as well.
