The bids will be publicly opened and read at the City of Swainsboro City Hall, 101 West Main Street. No submitted bid may be withdrawn after the scheduled closing time for receipt of bids for a period of sixty (60) days.

The Georgia Department of Transportation Standard Specifications, Latest Edition, Supplemental Specifications Book, Latest Edition, and applicable Supplemental Specifications and Special Provisions apply to this project.

Work to be done: The work to be done consists of furnishing all materials, equipment and labor for the construction of:

Part A – Swainsboro 2018 LMIG

The project will consist of concrete patching, bitum tack coat, overlay with 2,483 tons of recycled asphalt concrete 9.5 mm Superpave, traffic control, and appurtenances.

Part B – Swainsboro 2019 LMIG

The project will consist of concrete patching, bitum tack coat, overlay with 2,299 tons of recycled asphalt concrete 9.5 mm Superpave, traffic control, and appurtenances.

Part C – Twin City 2018 LMIG

The project will consist of installation of concrete patching, adjusting water valves, bitum tack coat, overlay with 373 tons of recycled asphalt concrete 9.5 mm Superpave, restriping, traffic control, and appurtenances.

Part D – Twin City 2019 LMIG

The project will consist of installation of concrete patching, bitum tack coat, 123 tons of recycled asphalt leveling, overlay with 310 tons of recycled asphalt concrete 9.5 mm Superpave, restriping, traffic control, and appurtenances.

Time allotted for the completion of Part A through D shall be 120 consecutive calendar days.
